*"Available Cash" means cash held by a Cell after deduction for any accrued fees and expenses but, for the avoidance of doubt, excludes cash required to pay the premia on Current Underlying Investments from time to time attributable to the Cell for a specified period which will be retained by the relevant Cell or one or more subsidiaries of the Fund. In calculating the level of Available Cash for each Cell at 31 January 2018, the directors excluded an amount consisting of cash and receivables to pay the premia on Current Underlying Investments for one year which means that \$37.5m in aggregate was excluded across all Cells when determining the level of Available Cash.
